## Proceedings of the Governing Body meeting of Gunupur Degree College, Gunupur held on 07.02.2022 at 4.00PM in the college premises

A meeting of the Governing Body of Gunupur Degree College, Gunupur was held on 07.02.2022 at 4.00PM in the college . The meeting was presided over by Sri Mohan Chandra Sahu, President , Governing Body of the college.

The following resolutions were adopted in the meeting :

### Resolution -I :

The State Govt. with the approval of State Cabinet has been pleased to regularize the unauthorized occupation of Govt. land by Aided Degree Colleges and Higher Secondary Schools in the State , vide G.O. No-35491 dated.25.11.2021. As per the policy , the land will be recorded in the name of Higher Education Department and School and Mass Education Department .

Further, the Principal of the Non-Govt. Aided college being the Ex-officio Secretary of the Governing Body , is as such competent to apply for necessary land lease / alienation to the local Tahasildar (vide letter No-28778 /HE dated.06.12.2019). The Govt. of Odisha in the department of Higher Education has authorized the principals of Non-Govt. Aided colleges to file for land lease / alienation application (vide letter No.2520 dated.19.01.2022)

After careful consideration, the Governing Body has decided for the alienation of land in favour of Gunupur Degree College, Gunupur and Higher Secondary School ,Gunupur as such:

**Resolution -II:**

Further, Director of Higher Secondary Education , Odisha , vide letter No. 1164 dated.01.02.2022 instructed for the demarcation of infrastructural facilities and alienation of Higher Secondary School and Aided colleges of the State .

Further , a district level committee meeting was held on 07.02.2022 at 10.30AM at Chintan Conference Hall, Collectorate , Rayagada under the chairmanship of esteemed Collector, Rayagada wherein , it was decided to separate Higher Secondary Schools from Composite Degree Colleges .

After careful consideration , the Governing Body decided for the separation of infrastructure of Higher Secondary School from composite degree college , that is, 2.02 acres in favour of Higher Secondary School and 4.0 acres in favor of Gunupur Degree College . The demarcation is as follows :
